Important Dates – Mark Your Calendar

The IRS Tax Calendar for Small Businesses and the Self Employed is follows:

> DECEMBER 2016

<u>12/23/2016</u>

• Deposit payroll tax for payments on Dec 17-20 if the semiweekly deposit rule applies.

12/29/2016

Deposit payroll tax for payments on Dec 21-23 if the semiweekly deposit rule applies.

12/30/2016

- File Form 730 and pay tax on wagers accepted during November.
- File Form 2290 and pay the tax for vehicles first used during November.
- Deposit payroll tax for payments on Dec 24-27 if the semiweekly deposit rule applies.

JANUARY 2017

01/03/2017

- File Form 730 and pay the tax on wagers accepted during Nov 2016.
- File Form 2290 and pay the tax for vehicles first used in Nov 2016.

01/05/2017

Deposit payroll tax for payments on Dec. 28-30 if the semiweekly deposit rule applies.

01/06/2017

• Deposit payroll tax for payments on Dec 31-Jan 3 if the semiweekly deposit rule applies.

01/10/2017

Employers: Employees are required to report to you tips of \$20 or more earned during Dec 2016

01/11/2017

• Deposit payroll tax for payments on Jan 4- 6 if the semiweekly deposit rule applies.

01/13/2017

• Deposit payroll tax for payments on Jan 7-10 if the semiweekly deposit rule applies.

01/17/2017

- Pay the final installment of your 2016 estimated tax use Form 1040-ES.
- Farmers and fishermen: Pay your estimated tax for 2016. Use Form 1040-ES.
- Deposit payroll tax for Dec 2016 if the monthly deposit rule applies.

01/19/2017

Deposit payroll tax for payments on Jan 11-13 if the semiweekly deposit rule applies.

01/23/2017

Deposit payroll tax for payments on Jan 14-17 if the semiweekly deposit rule applies.

01/25/2017

Deposit payroll tax for payments on Jan 18-20 if the semiweekly deposit rule applies.

01/27/2017

Deposit payroll tax for payments on Jan 21-24 if the semiweekly deposit rule applies.

01/31/2017

- Individuals: File your tax return if you did not pay your last installment of estimated tax by Jan 17th (see Form 1040-ES)
- File Form W-3 with Copy A of all Forms W-2 issued for 2016.
- Furnish Forms 1098, 1099 and W-2G to recipients for certain payments during 2016. Furnish Form W-2 to employees who worked for you during 2016.
- File Form 720 for the fourth quarter of 2016.
- File Form 730 and pay the tax on wagers accepted during Dec 2016.
- File Form 2290 and pay the tax for vehicles first used in Dec 2016.
- File Forms 940, 941, 943, 944 and/or 945 if you did not deposit all taxes when due.
- Deposit any FUTA tax owed through Dec 2016.

FEBRUARY 2017

02/01/2017

Deposit payroll tax for payments on Jan 25-27 if the semiweekly deposit rule applies.

02/03/2017

Deposit payroll tax for payments on Jan 28-31 if the semiweekly deposit rule applies.

02/08/2017

Deposit payroll tax for payments on Feb 1-3 if the semiweekly deposit rule applies.

02/10/2017

- Employers: Employees are required to report to you tips of \$20 or more earned during Jan.
- File Forms 940, 941, 943, 944 and/or 945 if you timely deposited all required payments.
- Deposit payroll tax for payments on Feb 4-7 if the semiweekly deposit rule applies.

02/15/2017

- File a new Form W-4 if you claimed exemption from income tax withholding in 2016.
- Furnish Forms 1099-B, 1099-S and certain Forms 1099-MISC to recipients.
- Deposit payroll tax for Jan if the monthly deposit rule applies.
- Deposit payroll tax for payments on Feb 8-10 if the semiweekly deposit rule applies.

02/16/2017

 Begin withholding on employees who claimed exemption from withholding in 2016 but did not file a W-4 or W-4(SP) to continue withholding exemption in 2017.

02/17/2017

• Deposit payroll tax for payments on Feb 11-14 if the semiweekly deposit rule applies.

02/23/2017

• Deposit payroll tax for payments on Feb 15-17 if the semiweekly deposit rule applies.

02/24/2017

• Deposit payroll tax for payments on Feb 18-21 if the semiweekly deposit rule applies.

02/28/2017

- File Form 1096 along with Copy A of Form W-2G issued during 2016.
- File Form 8027 if you are a large food or beverage establishment.
- File Form 730 and pay the tax on wagers accepted during January.
- File Form 2290 and pay the tax for vehicles first used in January.
- Applicable Large Employer: File paper Forms 1094-C and 1095-C; For all other providers file paper Forms 1094-B and 1095-B with the IRS

> MARCH 2017

03/01/2017

- Farmers and fishermen: File Form 1040 and pay any tax due. However, you have until Apr 18 to file if you paid your 2016 estimated tax payments by Jan 17, 2017.
- Deposit payroll tax for payments on Feb 22-24 if the semiweekly deposit rule applies.

03/02/2017

 Applicable Large Employers provide Forms 1095-C to full time employees; For all other providers of Minimum Essential Coverage, provide Forms 1095-B to responsible individuals.

03/03/2017

• Deposit payroll tax for payments on Feb 25-28 if the semiweekly deposit rule applies.

03/08/2017

Deposit payroll tax for payments on Mar 1-3 if the semiweekly deposit rule applies.

03/10/2017

- Employers: Employees are required to report to you tips of \$20 or more earned during February.
- Deposit payroll tax for payments on Mar 4-7 if the semiweekly deposit rule applies.

03/15/2017

- Deposit payroll tax for Feb if the monthly deposit rule applies.
- S Corps: File Form 1120S for calendar year and pay any tax due. Give copy of Sch. K-1 to each shareholder. File Form 2553 to elect S Corp status beginning with calendar year 2017. For automatic 6-month extension, file Form 7004 and deposit estimated tax.
- Partnerships: File Form 1065 for the calendar year and furnish a copy of Sch. K-1 to each partner. File Form 7004 for extension (see instructions).
- Electing Large Partnerships: File Form 1065-B calendar year return. Furnish Sch. K-1 to each partner. File Form 7004 for extension (see instructions).
- Deposit payroll tax for payments on Mar 8-10 if the semiweekly deposit rule applies.

03/17/2017

• Deposit payroll tax for payments on Mar 11-14 if the semiweekly deposit rule applies.

03/22/2017

Deposit payroll tax for payments on Mar 15-17 if the semiweekly deposit rule applies.

03/24/2017

Deposit payroll tax for payments on Mar 18-21 if the semiweekly deposit rule applies.

03/29/2017

Deposit payroll tax for payments on Mar 22-24 if the semiweekly deposit rule applies.

03/31/2017

- File Form 730 and pay the tax on wagers accepted during February.
- File Form 2290 and pay the tax for vehicles first used in February.
- Electronically file Forms W-2, W-2G, 1098, 1099, 8027, 1094-C, 1095-C, 1094-B, and 1095-B.
- Deposit payroll tax for payments on Mar 25-28 if the semiweekly deposit rule applies.

APRIL 2017

04/05/2017

• Deposit payroll tax for payments on Mar 29-31 if the semiweekly deposit rule applies.

04/07/2017

Deposit payroll tax for payments on Apr 1-4 if the semiweekly deposit rule applies.

04/10/2017

• Employers: Employees are required to report to you tips of \$20 or more earned during March.

04/12/2017

• Deposit payroll tax for payments on Apr 5-7 if the semiweekly deposit rule applies.

04/14/2017

Deposit payroll tax for payments on Apr 8-11 if the semiweekly deposit rule applies.

04/18/2017

- Individuals: File Form 1040, 1040A, or 1040EZ. For automatic 6-month extension file Form 4868 and deposit estimated tax. Pay the first installment of 2017 estimated tax Use Form 1040-ES.
- Corporations: File Form 1120 for calendar year and pay any tax due. For automatic 5-month extension, file Form 7004 and deposit estimated tax.
- Household Employers: File Sch. H with Form 1040 if you paid \$2,000 or more to a household employee.
- Corporations: Deposit the first installment of your 2017 estimated tax.
- Deposit payroll tax for Mar if the monthly deposit rule applies.

04/20/2017

Deposit payroll tax for payments on Apr 12-14 if the semiweekly deposit rule applies.

04/21/2017

Deposit payroll tax for payments on Apr 15-18 if the semiweekly deposit rule applies.

04/26/2017

• Deposit payroll tax for payments on Apr 19-21 if the semiweekly deposit rule applies.

04/28/2017

Deposit payroll tax for payments on Apr 22-25 if the semiweekly deposit rule applies.
